## FRAUD, WASTE AND ABUSE

# Promote safe and effective health outcomes through clinically based identification, intervention and monitoring of fraud, waste and abuse behaviors.

Hundreds of millions of dollars are spent annually on opioid analgesics (commonly known as narcotics) prescribed to manage pain from workers' compensation injuries. *PMSI's Annual Drug Trends Report* shows that over 75% of total pharmacy spend is related to medications used for the treatment of pain. The absence of co-pays and out-of-pocket costs for workers' compensation claims makes it easy for injured workers to fill every prescription, whether or not it is needed. A lack of clinical oversight removes barriers to obtaining multiple prescriptions by doctor shopping while an increase in physician dispensing has led to the proliferation of clinics that distribute drugs without medical cause.

Integrating established clinical strategies to identify, alert and intervene with aberrant high-risk prescribing and dispensing patterns and therapeutic care for the injury, PMSI's Fraud, Waste and Abuse specialty program can resolve concerns and prevent potential incidents to reduce unnecessary risks and costs. The multi-faceted program concentrates on three communities of interest involved throughout the claim lifecycle:

- Injured workers
- Physicians
- Pharmacies

PMSI's Fraud, Waste and Abuse program evaluates at both the population and individual levels to identify high-risk behaviors within these communities of interest. PMSI's owned network of nearly 65,000 participating retail pharmacies nationwide, maintains rigorous audit practices and point-of-sale safeguards that reduce potential instances of fraud, waste and abuse at the pharmacy level.

The **Population Risk Scorecard** predicts risk within the injured worker population from medication use. Applying a proprietary set of criteria to prescription claims, clients can focus on the segment of the claimant population exhibiting utilization behaviors inconsistent with best-practice clinical guidelines and evidence-based medicine. The **Prescriber Profiling Report** identifies prescribing behaviors outside normal parameters identified as high-risk. Clients receive a custom report listing any prescribers exhibiting high-risk behavior associated with claims in the payor's population. A list of indicators on which the high-risk classification is based and claimant/transactional data for the associated claims is included in the report. As part of the Population Risk Scorecard and the Prescriber Profiling Report, PMSI provides recommendations on available intervention options to resolve the issues to mitigate risk and ensure positive health outcomes for injured workers.

### Proven Solution: Fraud, Waste and Abuse

Using the capabilities of the MedAssess Risk IS™, all transactions are analyzed through a multi-dimensional model that recognizes key indicators to trigger alerts, recommends interventions, and continuously monitors injured workers, pharmacies and physicians exhibiting behaviors potentially related to fraud, waste or abuse scenarios.

- High-Risk Profiling Flags irregular behavior involving narcotic prescribing and utilization within the physician and injured worker communities
- Medication Reviews and Peer-to-Peer Outreach Evaluates appropriateness of prescribed therapy for the injury, which
  may require a peer-to-peer review
- Drug Testing and Monitoring Assesses the proper use of prescribed medication and detects the presence of any illegal drugs
- Generic Conversion Identifies when brand-to-generic conversion is not utilized
- Multiple Prescriber Outreach Converts multiple prescribers of narcotics to one lead prescriber
- Clinical Escalation Alerts Triggers alerts when transactions meet pre-defined clinical criteria specific to narcotics
